- This form must be submitted 15 business days prior to the date that the repoint will occur. Please refer to <u>Fedwire Services Production Environment Test information</u> located on FRBservices.org. Contact the Support Center to discuss available Saturday dates and times.
- This form accommodates alternate site processing in the **production** environment only. To process Fedwire funds messages from an alternate site in the DIT environment, complete and submit the Fedwire Application Test Request Form located on FRBservices.org.
