To: Out-of-Territory Depositors to the Cincinnati Office of the Federal Reserve Bank of Cleveland

**Accounting and Billing Changes –
Cincinnati, Indianapolis, Louisville, and Charleston Paper Check Processing Moving to
the Federal Reserve Bank of Cleveland**

As we announced to you in previous communications, Cincinnati, Indianapolis, Louisville, and Charleston paper check processing moves to the Federal Reserve Bank of Cleveland effective close of business Friday, October 17. After that date all items previously deposited at the Cincinnati office should be deposited at the Cleveland Office. Some changes will appear on your Statement of Account and Statement of Service Charges as a result of this move. Attachment I outlines these changes, which will be effective Monday, October 20, the first business day after the October 17 move. Please share all attachments with others in your organization who may find them useful.

Change in Statement of Account

Cost Center Work Unit (CCWU) Numbers

CCWU number 9911 on your Statement of Account today will change to 9910, the CCWU of the Cleveland office.

Changes in Statement of Service Charges and Billing Product Codes

On your October 2008 billing statement, you will notice two changes to your Statement of Service Charges.

- First, items deposited after October 17 will appear as being processed by the Cleveland office.
- Second, you will begin to see changes to some billing product codes. Some of the items deposited after October 17 will be billed under different product codes than they are today. Please note actual fees for these products will not change. A conversion table of billing product code changes may be found in Attachment II.

Once Cincinnati paper processing moves to Cleveland, all billing adjustments will appear on the Statement of Service Charges as originating from the Cleveland office, even if the items were originally processed in Cincinnati. Billing adjustments for items processed by Cincinnati before the move, but functioned after October 17, therefore, will appear as being processed by Cleveland.

Assistance in Managing Your Account Going Forward

To assist in managing your FRB account both during this time of transition and on an ongoing basis, the Federal Reserve offers a number of Accounting Information Services. These services include delivery of your daily Statement of Account, Cash Management Reports, online inquiry capabilities to view transactions, notifications of entries to your account and the Monthly Summary Statement of Service Charges. This information can be delivered to you via FedLine® Web or FedMail® (e-mail or fax). We also offer enhanced cash management features via FedLine Web or computer interface connection, including intra-day account information on nearly a real-time basis. Customer Testing Information and a Final Note

Minimizing the impact of operational changes for our customers is one of our highest priorities during the check restructuring initiative. We anticipate accounting processes not mentioned in this letter will continue as they are today. We encourage you, however, to conduct testing on accounting information. Please watch for additional information concerning our restructuring initiative as we draw closer to October 17. In the meantime, please contact your account executive if you need further information.
