





How To Obtain Your MyStandards Credentials


To obtain access to the Federal Reserve Financial Services' MyStandards web portal, you need to create a swift.com account following the below steps after clicking this [link](#).

1. Create account.



Note: If you already have a swift.com account, you can reuse your existing credentials.¹

2. Fill in the User Registration information.



¹ MyStandards is a standards management tool operated by Swift and is not owned by the Federal Reserve Banks. Federal Reserve-issued credentials (e.g., FedLine®) will not work on the MyStandards website.

3. Confirm your registration.

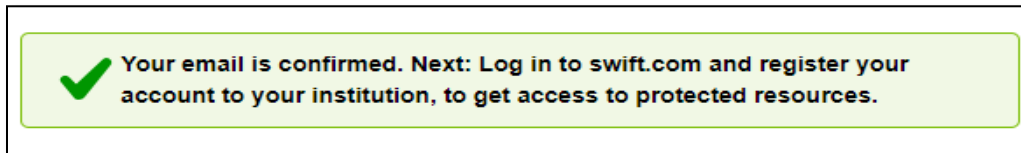
The below box will appear, and you will receive an email to finalize your account creation.



Follow the link in the email to accept the *Terms of Use* and *Privacy Statement* and confirm your account creation.

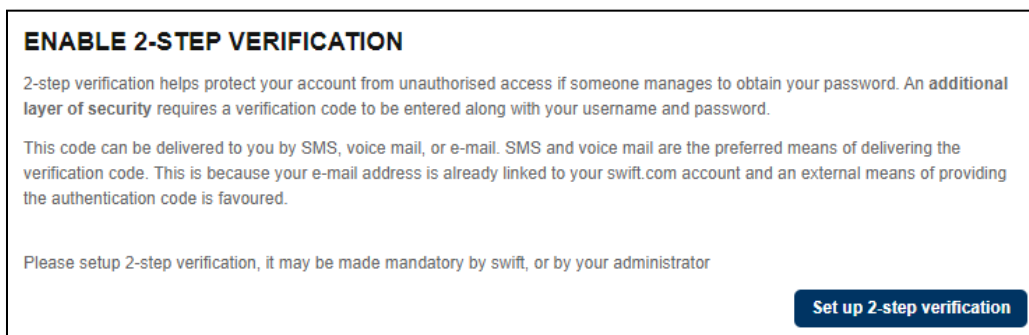


Your account creation will be confirmed as shown below.



4. Set up your 2-step verification.

Sign in with your newly obtained credentials to set up your 2-step verification.



Select the 2-step verification channel of your choice.

Manage 2nd factor & 2-step verification settings

To start using 2-step verification you need to enable at least one of the channels below. We recommend that you enable multiple channels to ensure that you can access your account at all times.

5. Request access to the Fedwire Funds Service Sub-group.

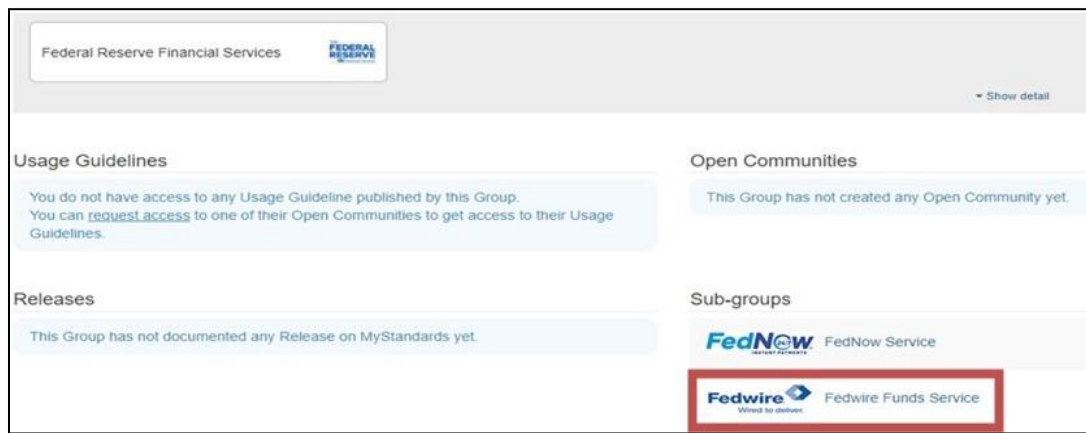

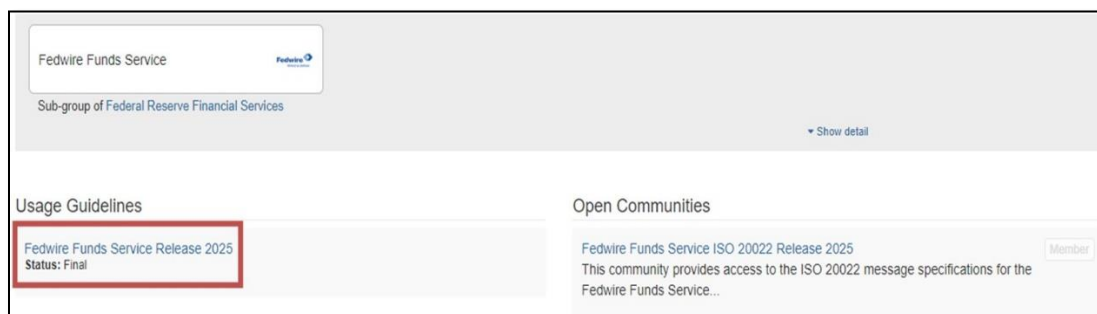
