SUBJECT: Unilateral Repo Adjustments

As previously announced in Clearing Memorandum #236, Fedwire® Securities Service participants will be permitted on payment date to unilaterally cancel a preauthorized debit associated with a Repo Claim Adjustment to another Fedwire participant. This will be done by submitting a Unilateral Adjustment Request to the Federal Reserve, with the understanding that the Fedwire participant sending the request has not notified the Fedwire participant counterparty and has no agreement from that counterparty. Fedwire participants will also be able to reinstate the payment of the preauthorized debit associated with a Repo Claim Adjustment to another Fedwire participant. Detailed below are the procedures to effect these adjustment requests.

Operating Circular No. 7, "Book-Entry Securities Maintenance and Transfer Services," will reflect that the Federal Reserve accepts unilateral requests to cancel or reinstate a payment of the preauthorized debit associated with a Repo Claim Adjustment to another Fedwire participant. Revisions to Operating Circular 7 will be made in the near future. The current Operating Circular No. 7 is posted to the Financial Services web-site ([www.frbfinancialservices.org](http://www.frbfinancialservices.org)).

### A. Request Messages

#### 1. Unilateral Request: Cancel Payment Message

The Federal Reserve will only accept a unilateral request to cancel or reinstate payment on a Repo claim adjustment via the type code 2090 service message for the current payment date. Only one request per message is permitted. The request will be accepted on **payment date only** up until 11:00am ET. The submitter, Bank A, will send the 2090 service message to the FRB NYC/UADJ (see attachment 1 for an example). The request should be sent using the normal delivery instructions contained in a repo securities transfer message.

In addition, the submitter must include in free text line 1, the following information in the order listed:

- Dollar Amount of cancelled/reinstated payment
- Payment date (PD: mmddyy)
- Submitter ABA number
- Submitter bank name
- Submitter securities account
- 3<sup>rd</sup> party info (if available)

In the "Sending Bank Info" field on line 4, please include a contact name and phone number. If omitted the request will be returned as "missing required info" (see section C – Denial Messages).

The submitter must also include in free text line 2, the **Counterparty** information in the order listed:

Counterparty ABA number  
Counterparty bank name  
Counterparty securities account and/ or 3<sup>rd</sup> party info  
Counterparty contact name and phone number (if available)

2. Unilateral Request: Reinstate Payment Message

To reinstate a payment, the original Fedwire Participant that submitted the Cancel Payment Request, must send a 2090 service message to the FRB NYC/UADJ, with all the information from the original request and also include in the "Sending Bank Info" field on line 4, the following "UNI REIN REQ" (see attachment 1).

**B. Confirmation Messages**

1. Unilateral Request: Cancel Payment Message

The Federal Reserve will send a 2090 service message confirming that a Unilateral request has been received and processed to both Fedwire Participant A and Fedwire Participant B. The message will be sent from FRB NYC/UADJ. This confirmation will be sent by 12:00pm ET on the same business day of receipt of the request (see attachment 2 for an example). The message will include all the information on the original request, and the following in the "Sending Bank Info" field on line 4:

For the Submitter Bank - UNI CANC RCD AND PRC  
Unilateral Cancel Payment Request Received and Processed

For the Counterparty Bank - UNI CANC REQ PRC  
Unilateral Cancel Payment Requested Processed

2. Unilateral Request: Reinstate Payment Message

The Federal Reserve will send a 2090 service message confirming that the Unilateral Adjustment request has been reinstated to both Fedwire Participant A and Fedwire Participant B from FRB NYC/UADJ. This confirmation will be sent by 12:00 pm ET on the same business day of receipt of the request (see attachment 3 for an example). The message will include all the information on the original request, and the following in the Sending Bank Info line:

For the Submitter Bank - UNI REIN RCD AND PRC  
Unilateral Adjustment Reinstatement Request Received and Processed

For the Counterparty Bank - UNI REIN REQ PRC  
Unilateral Adjustment Reinstatement Request Processed

**C. Denial Messages**

Unilateral Request Denial Message

Unilateral requests may be denied for the reasons listed below. If this occurs, a 2090 service message will be sent to the submitter indicating the reason in the Sending Bank Info field on line 4, that the request has been denied:

**PAST CUT OFF**

The 2090 service message is received after 11:00 am, ET on the payment date (see attachment 4 for an example).

**MISSING REQUIRED INFO**

The 2090 service message is missing or has incomplete information on section A.

**INCORRECT AMOUNT**

The "dollar amount " to be cancelled on the 2090 service message is greater than the preauthorized debt amount.
